## Switzerland Point Middle School **BEYOND THE BELL**

We have read and reviewed the Switzerland Point **Beyond the Bell** Handbook. We understand the policies and procedures explained within the handbook

**We understand that Extended Day Care is a PRIVILEGE NOT A RIGHT. If a child shows or continues to show inappropriate or disruptive behavior, they may be removed from the program to insure a pleasant environment for the other students. Make sure to go over the rules with your child, as BOTH will be held accountable. Please pay attention to any notes sent home concerning inappropriate behavior. **Medical Release for Care & Treatment:** In case of accident or serious illness during Extended Day hours, SPMS will contact the legal GUARDIAN. Switzerland Point Middle School's **Beyond the Bell** program (**SPMS BTB**) may make whatever arrangements necessary to provide care and treatment for my child including contacting a physician. In case of an emergency, I hereby give **SPMS BTB** permission for my child to be transported by Emergency Medical Services to the hospital and given necessary treatment. I understand I will be responsible for any and all related charges. In the case of an accident or serious illness where immediate treatment of my child is not indicated but where he/she is unable to remain in school, **SPMS BTB** will contact the parent to arrange pick-up of the child. If **SPMS BTB** is unable to reach me, I authorize them to contact one of the persons listed on their registration form and request them to come to the school and transport my child home/to their home. I understand that it is the parent/guardian's responsibility to notify the school of any changes in the information throughout the school year.

**General Release of Liability:** The undersigned agrees to release and forever discharge Switzerland Point Middle School Extended Day program, St. Johns County School District, St. Johns County School Board, their officers, servants, agents, and employees, from all claims, demands, rights and causes of action of any kind the undersigned now has or hereafter may have on account of or in any way arising from personal injuries and or property damage known or unknown to the undersigned at the present time that results from any occurrences which may happen to the below stated child during time spent in the Switzerland Point Middle School Extended Day program, barring proven supervisory neglect.

**Late Pick-Up Fees:** \$1.00 per minute after 6:00. Money is due upon pick-up.

**Late Monthly Payment Fees:** \$5.00 per day. Payment must be made PRIOR to your child attending BTB.
