Notable Changes in the 2013-14 Student Code of Conduct

- Added to page 14, “Responsibilities of the Bus Driver”, in the Transportation Chapter: **“Bus Drivers have authority to direct students to refrain from using CD players, iPods, or other musical devices on their bus.”**
- Added to page 15, “Responsibilities of the Student”, in the Transportation Chapter: “Refrain from using cell phones on bus. Refrain from using CD players, Ipods or other musical devices, **if directed by the Driver.**”
- Added to page 18, “Releasing Students from School” in the Attendance Chapter: **“It is the responsibility of the enrolling parent or guardian at the time of registration, to make sure the emergency contact card is accurate and complete. If a non-enrolling parent contends that he or she has been improperly omitted from the card, it is that parent’s responsibility to resolve the issue with the enrolling parent or seek a court order if the parties cannot resolve the issue.”**
- Added page 21, “Drugs” in the Student Discipline Chapter: Added **“...including household products,”** to the list of items not tolerated. Also added **“While on school property, school bus, or school-approved transportation, or at any school-related function or activity, students are prohibited from planning, intending or committing any act in furtherance of the possession, use, delivery, purchase, or sale of drugs, counterfeit drugs or drug paraphernalia.”**
- Added to page 23, “Search and Seizure” in the Student Discipline Center: **“Students are responsible for the contents of any vehicle they possess on school grounds and shall be deemed to be in possession of any contraband contained within their vehicle.”**
- Noted, on page 27, added an additional “SECTION”, separating the Levels of Discipline and putting all four Levels into their own section.
- Added on page 27, added to the definition of Disorderly Conduct under the list of Level I infractions, **“...i.e. horseplay in hallways, inappropriate behavior in lunchroom.”**
- Added on page 30, to Bullying, **“or use of digital technologies that include...”**
- Added on page 32, to G. Drugs, “possessing, using, delivering, **buying,** selling, intending to sell, or being under the influence or any drug or counterfeit drug, **or planning, intending or committing any act in furtherance of the possession, use, distribution, purchase or sale of drugs, counterfeit drugs, or drug paraphernalia.** This offense also includes possession, use, **buying,** delivering or sale of drug paraphernalia.”
- Added on page 33, to S. Other, **“This also includes the planning or commission of any act in furtherance of a Level IV offense or felony.”**
- Added on page 48 to “Student-Athlete Code of Conduct”: **“This component will occur after school hours and will take place at the location of the provider in partnership with the St. Johns County School District.”**
- Added on page 59 to Release of Student Directory Information Options: **“3. I request that no Student Directory information, including photographs and video (as outlined in Section 6 of the Student Code of Conduct,) be released.”**
